ORDER

CHANGE OF NAME OF THE INSTITUTION AND AFFILIATING BODY

WHEREAS, the recognition was granted to the institution namely **Chitkara College of Education for Women, SCO,223, Sector-36, D, Chandigarh-160036** for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2003-2004 vide order No. NRC/NCTE/F-3/PB-105/2003/1954 dated 26.06.2003 followed by the Corrigendum Order No.F.NRC/NCTE/F-3/PB-105/2003/2290-2296 dated 04.07.2003 regarding change the address of the institution from "SCO-223, Sector-36-D, Chandigarh-160036" to "Village-Fatehpurgarhi, Tehsil Rajpura, Distt. Patila, Punjab".

2. AND WHEREAS, the revised recognition order was issued to the institution vide order No. NRC/NCTE/PB-105/2015/105611-16 dated 27.05.2015 with an annual intake of 100 students (two units of 50 students each from the academic session 2015-16.

3. AND WHEREAS, as per decision of NRC in its 267th Meeting (part-3), change of the name of the institution from "Chitkara College of Education for Women" to "Chitkara College of Education" was allowed and accordingly order was issued on 29.04.2017.

4. AND WHEREAS, as per the decision of the NRC in its 408th meeting, the recognition for the B.Ed. course was withdrawn vide order dated 17.10.2023.

5. AND WHEREAS, as per the decision of the NRC in its 423rd Meeting held on 15th July 2024, the recognition for B.Ed. Course was restored by NRC vide order dated 30.09.2024.

6. AND WHEREAS, the above institution has been running under the Chitkara Educational Trust, Address-1097, Sector 18-C, Chandigarh which has now established a private University namely "Chitkara University, Punjab" vide gazette notification published in "Punjab Government Gazette (Extra) November 25, 2010, through Punjab Act no 23 of 2010 in the name of "The Chitkara University Act, 2010".

7. AND WHEREAS, the Society vide letter dated 24/04/2025 has requested the Northern Regional Committee to change the name of the institution located in the campus of Chitkara University, Punjab and to change the affiliating University.

8. AND WHEREAS, the matter was placed before NRC in its 439th Meeting held on 05th to 06th May, 2025, and the Committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -

- *The recognition was granted to the institution namely Chitkara College of Education for Women, SCO,223, Sector-36, D, Chandigarh-160036 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2003-2004 vide order No. NRC/NCTE/F-3/PB-105/2003/1954 dated 26.06.2003. The Corrigendum order No. F.NRC/NCTE/F-3/PB-105/2003/2290-2296 dated 04.07.2003 was issued to the institution regarding change the address of the institution from "SCO-223, Sector-36-D, Chandigarh-160036" to "Village-Fatehpurgarhi, Tehsil Rajpura, Distt. Patiala, Punjab".*
- *The revised recognition order was issued to the institution vide order No. NRC/NCTE/PB-105/2015/105611-16 dated 27.05.2015 with an annual intake of 100 students (two units of 50 students each from the academic session 2015-16.*
- *Subsequently, as per decision of NRC in its 267th Meeting (part-3), change of the name of the institution from 'Chitkara College of Education for Women' to 'Chitkara College of Education' was allowed and accordingly order was issued on 29.04.2017.*
- *As per the decision of the NRC in its 408th Meeting, the recognition for the B.Ed. course was withdrawn vide order dated 17.10.2023.*
- *As per the decision of the NRC in its 423rd Meeting held on 15th July 2024, the recognition for B.Ed. Course was restored by NRC vide order dated 30.09.2024.*
- *The above institution has been running under the Chitkara Educational Trust, Address-1097, Sector 18-C, Chandigarh which has now established a private University namely "Chitkara University, Punjab" vide gazette notification published in "Punjab Government Gazette (Extra) November 25, 2010, through Punjab Act no 23 of 2010 in the name of "The Chitkara University Act, 2010".*
- *The society vide letter dated 24/04/2025 has requested the Northern Regional Committee to change the name of the institution located in the campus of Chitkara University, Punjab and to change the affiliating University.*

In view of the above, the Committee permitted as under:

- a) *The name of the institution be changed from Chitkara College of Education, Village-Fatehpurgarhi, Tehsil - Rajpura, Distt. Patiala, Punjab to the Department of Education, Chitkara University, Punjab for offering its B.Ed. Course.*
- b) *The affiliating body be changed from Punjabi University, Patiala to the Chitkara University, Punjab for B.Ed. Course."*

Orders be issued accordingly.



9. **NOW THEREFORE**, in terms of the above decision of NRC, the institution namely **Chitkara College of Education, Village-Fatehpurgarhi, Tehsil - Rajpura, Distt. Patiala, Punjab** is hereby changed as **Department of Education, Chitkara University Punjab, Village-Fatehpurgarhi, Tehsil - Rajpura, Distt. Patiala, Punjab - 140401** and the name of the affiliating body from **Punjabi University, Patiala** to the **Chitkara University, Punjab**.
