



# 5-YEAR B.A. LL.B. (HONS.)

The 5-Year B.A. LL.B. (Hons.) program at Chitkara Law School offers an intellectually rich blend of academic theory, practical exposure and multidisciplinary learning. It equips students with a profound understanding of the Indian legal system while building analytical precision, ethical judgement, and a problem-solving mindset vital for thriving in the legal profession.

Spanning a carefully designed curriculum, the program explores the structure and functioning of legal institutions, procedural laws, and policy frameworks that guide governance and justice in India. Students specialise in areas such as Constitutional Law, Corporate and Business Law, Criminal Law, International and Human Rights Law, developing focused expertise within their domain of interest.

By integrating humanities disciplines like History, Political Science, Economics, and Sociology, students gain insights into the complex social, political, and economic factors that influence legislation and judicial decisions. This multidimensional perspective equips them to interpret and apply the law holistically.

Practical learning is central to the program through Legal Internships, Clinical Courses, Research Projects, and Advocacy Workshops, which are all approved by the Bar Council of India. These experiences help students translate classroom knowledge into courtroom practice and policy solutions.

# PROGRAM STRUCTURE

Chitkara Law School's 5-Year B.A. LL.B. (Hons.) program is a specialised honours program that gives you the critical thinking, communication, and advocacy skills to prepare you for a successful legal career. The program is offered with five specialisation options including corporate law, intellectual law, property law, criminal law, constitutional law and trade and investment law. Our academic curriculum allows you to integrate theory and practice with a variety of clinics, practicum courses, and externship opportunities.

In clinics and practicums, you'll engage in all phases of client representation, including litigation planning, interviewing, counselling, legal drafting, negotiating and trial and appellate advocacy including ADR practices. There will also be career talks from local law firms and relevant organisations throughout the duration of the program to help you make an informed decision.

The B.A. LL.B. (Hons.) program is divided into 10 semesters. Each semester has a specified number of subjects with credits awarded for each accordingly. The program covers subjects relating to various laws, sociology, economics, history, political science, etc. During the first six semesters, various laws and specific disciplines are combined, along with English and a foreign language as part of the syllabus.

The last four semesters focus on advanced legal topics, giving students the opportunity to specialise in areas of their interest, such as criminal law, corporate law, or intellectual property law, constitutional law and trade and investment law. This is complemented by internships and seminars, providing real-world exposure and the chance to work closely with legal professionals. You will also be involved in moot court competitions and legal aid programs, which foster a deep understanding of the practical aspects of law.



# **PROGRAM OUTCOMES**

Having implemented Outcome-Based Education (OBE), our 5-Year B.A. LL.B (Hons.) program is designed with a strong student- centric teaching framework.

A student completing the program will develop:

- Effective communication proficiency in persuasive oral and written communication through drafting, mooting, advocacy, teamwork, collaboration, and professional networking.
- Adaptability and versatility the ability to respond to evolving legal landscapes and excel across a wide range of professional roles.
- Professionalism and leadership a strong sense of ethics, public responsibility, and readiness to lead law reforms, demonstrating the highest professional standards. Graduates will be equipped for diverse careers in public service, private practice, academia, or entrepreneurship, leveraging their research skills and legal insight.
- Intercultural and ethical competence sensitivity to issues of social justice, global citizenship, and community legal care, with acommitment to fairness and equity.
- Environmental and cultural awareness empathy towards the disadvantaged and the environment, and cultural sensitivity in national and international contexts to effectively address ethical dilemmas.



# SPECIALISATIONS OFFERED

During the course of the Program , students will have the option to do Electives in the specialisation of their choice. Some of the specialisations offered at Chitkara Law School are

#### **Corporate Law**

This specialisation builds expertise in company law, mergers, acquisitions & corporate governance. Alongside learning business regulations, compliance & financial laws, students gain hands-on experience through internships & case studies. Students learn to advise corporations, startups and financial institutions on legal and strategic matters and are ready for roles in top law firms, regulatory bodies & corporate legal departments.

#### **Intellectual Property Law**

This specialisation focuses on copyright, patents, trademarks and digital rights and practical training in IP drafting, litigation and strategy. Graduates are prepared to guide creators, businesses and research organisations in safeguarding intellectual assets and navigating the evolving digital economy.

#### **Criminal Law**

This specialisation grooms graduates for roles like criminal lawyers, prosecutors, policy advisors or legal consultants. It incorporates moot courts, simulations and internships with legal institutions. Students explore contemporary concerns such as cybercrime, white-collar offences and victim rights.

#### **Constitutional Law**

Here, students delve into the legal foundations of governance, fundamental rights and constitutional interpretation. The carefully crafted curriculum lays emphasis on analytical reasoning, policy insight and legal drafting. Engagement with judicial decisions, constitutional reforms and internships helps students sharpen their critical perspective. Students graduating with this specialisation are well positioned for roles in litigation, policy analysis, academia or public service, contributing meaningfully to democratic institutions.

#### **Trade and Investment Law**

This specialisation explores global trade rules, investment treaties and international arbitration. Students learn to interpret WTO frameworks, bilateral agreements and cross-border legal systems, while moot courts and expert interactions bring practical context. With this global grounding, graduates are ready to advise governments, businesses and international organisations, building careers in trade policy, dispute resolution and international legal consulting.



# Positioning You For Success

B.A. LL.B. (Hons.) program at Chitkara Law School will prepare you for diverse career paths both within and outside of traditional legal practice, such as:

#### Litigation Lawyer

Start a career as an advocate, representing clients in court across various fields such as criminal law, civil rights, corporate disputes and family law.

#### Judiciary

Pursue a career as a judge by clearing judicial services exams, allowing you to preside over legal proceedings and make rulings.

## • Corporate Lawyer

Advises businesses on their legal rights, responsibilities and obligations. Handles mergers, acquisitions, contracts and compliance with corporate laws.

# In-House Counsel in Corporate Houses

Works directly within a corporation to provide ongoing legal advice and risk management related to daily business operations.

• Legal Officer in Public Sector

Provides legal support to the PSU by drafting and vetting contracts, handling litigation and ensuring compliance with law and regulations.

## • Judge Advocate General (JAG)

They prosecute or defend in military courts and ensure compliance with military law and international regulations.

# • Compliance Officer

Monitors and enforces adherence to legal and regulatory frameworks within the PSU, minimising legal risks.

# Prosecutor/District Attorney for Govt. agencies

Represents the government in criminal cases, responsible for proving the accused's guilt beyond a reasonable doubt.

# • Patent Lawyer

Advises clients on protecting their inventions, trademarks, copyrights and patents and handles litigation around intellectual property disputes.

## • Dispute Resolution Lawyer

Represents clients in resolving trade disputes through negotiation, arbitration, or litigation under international trade agreements.

#### Civil Services

Many graduates take the UPSC exam and join civil services by applying their legal knowledge to administrative roles.
