

**OFFICE ORDER**

Subject :- Constitution of University level Anti-Ragging Committee and squads and implementation of UGC guidelines for the Session 2026-27.

Reference :- In pursuance to the judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grant Commission framed "UGC Regulations on curbing the menace of Ragging in Higher Educational Institutions, 2009" which were notified on 17th June, 2009 and are to be mandatorily followed by all Universities and Colleges.

As per the directions of the Supreme Court of India and instructions from UGC, Chitkara University has constituted Anti-Ragging Committee and Anti-Ragging squads at Campus level to oversee different areas of the university for the implementation of the provisions of the verdict.

Punishments : The UGC vide its letter No. F.1-16/2007 (CCP-III) dated June 17, 2009, has reiterated ban on ragging. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the Institute, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:

1. Cancellation of admission.
2. Suspension from attending classes.
3. Withholding / withdrawing scholarship / fellowship and other benefits.
4. Debarring from appearing in any test / examination or other evaluation process
5. Withholding results.
6. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
7. Suspensions/ expulsion from the hostel.
8. Rustication from the institution for period varying from 1 to 4 semesters.
9. Expulsion from the institution and consequent debarring from admission to any other institution.
10. Fine up to Rs. 50,000/-.
11. Collective punishment: When the person committing or abetting the crime or ragging is not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

Following the orders of Hon'ble Supreme Court, UGC has made it mandatory that each student must submit an Anti-ragging affidavit at the time of first registration and annually thereafter (As per Anti Ragging Regulations Published in 2009).

The students are to follow the procedure as given below: -

1. Log on to www.antiragging.in or www.amanmovement.org.
2. Fill the information as requested.
3. Students will receive the affidavit through e-mail.
4. This must be printed and submitted to the University / College at the time of Admission or annual registration.

Anti-Ragging Committee/Anti-Ragging squads will submit a report to Director (University Affairs) for necessary directions.

Please note that the Director (University Affairs) will issue necessary guidelines to all schools / Departments for filling the Anti-Ragging on-line Affidavit by all the students, every year.

The Committee shall meet on a quarterly basis, but the Chairperson may direct additional meetings to be held as and when required.

The Minutes of Meeting shall be submitted to the Registrar's Office on a regular basis.

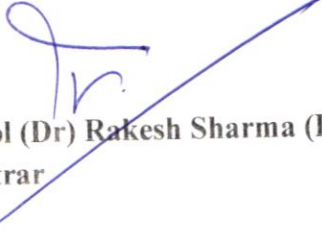

10. Fine up to Rs. 50,000/-.
11. Collective punishment:- When the persons committing or abetting the crime or ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

Following the orders of Hon'ble Supreme Court, UGC has made it mandatory that each student must submit an Anti ragging affidavit at the time of first registration and annually thereafter (As per Anti Ragging Regulations Published in 2009).

The students are to follow the procedure as given below:-

1. Log on to www.antiragging.in or www.amanmovement.org.
2. Fill the information as requested.
3. Student will receive the affidavit through e-mail.
4. This must be printed and submitted to University / College at the time of Admission or annual registration.

Anti-Ragging Committee/Anti-Ragging squads will submit report to Director (University Affairs) for necessary directions.

Please note that Director (University Affairs) will issue necessary guidelines to all School / Departments for filling Anti-Ragging on-line Affidavit by all the students, every year.

The Committee shall meet on quarterly basis, but the Chairperson may direct additional meetings to be held as and when required.

The Minutes of Meeting shall be submitted in the Registrar Office on regular basis .
