3.2. Installation support

The bidder will be responsible for delivery of the items to the Department of Optometry, SOAHS and the installation of the equipment wherever necessary.

4. Budget and payment terms

The bid amount should include equipment cost, installation cost, GST and other taxes, and all other cost envisaged to provide the services.

<u>Please note: The maximum budget foreseen for the work is 35,00,000 INR. The bid amount should not exceed the maximum budget.</u>

Payment will be processed within 45 days of full installation of equipment by the supplier. Any application/bid amount which is exceeding the maximum budget will be disqualified by default and will not be considered by the Tender Evaluation Committee.

Evaluation of the offer will mainly focus on the price and quality of services that the bidder plans to provide. Payments to the winning bidder will be transferred days upon producing the invoices/request for payment, respecting the terms and conditions mentioned in the contract signed between the supplier and MAHE.

Payment method – The amount will be transferred bank to bank electronically.

5. Time Frame

6. Documents required for tender application

- 6.1. Details of the company (e.g. Name. address, areas of operation etc.);
- 6.2. Detailed quotation with cost of equipment and services
- 6.3. Delivery schedule

The bidder shall submit the bid in detailed manner. The cost of equipment list shall include per unit cost, total cost, GST and taxes should be clearly mentioned in separate column. A recommended template to submit the 'Detailed list of cost of equipment and services' is provided at the end of the document.

7. How to Apply?

Applicants asked to carefully read and understand the needs of the tender fully before applying and that any queries be directed ASAP. If any problems of interpretation arise in the course of drawing up the Tender documents, interested parties may submit queries via e-mail for further information.

8. Evaluation and award of the contract

The Tender Evaluation Committee will evaluate the applications with respect to following criteria:

Exclusion Criteria

- a) If the bid amount exceeds the total cost of work (refer point 4)
- b) Incomplete applications
- c) If the vendor is not 'GST Registered'

Selection Criteria

- a) Price offered
- b) After-sale services offered (Installation, configuration, testing, AMC etc)
- c) Efficiency of delivery schedule

Award Criteria

The main emphasis will be on price offered by the bidder.

European Union's principle "Best value for money" of awarding contracts will be followed, meaning that the winning tender is the one offering the best quality/price ratio.
